

Prom Contract a.k.a RULES FOR THE PROM 2025

The 2025 Prom is a school sanctioned event. As such, all students must abide by the school code of conduct or face consequences as applied by the school for any failure to do so. All attendees at the Prom must agree to follow the Prom Contract 2025 as outlined below. Any student or guest that does not follow these rules will be asked to leave the premises and may face suspension from school. Each student or guest must sign this form to confirm the rules have been read, understood, and accepted before purchase of a ticket will be permitted. Tickets may be revoked without reimbursement if rules are not respected.

1. Any attendee or guest who arrives at the Prom under the influence of drugs or alcohol (as per the "reasonable belief" of Administration) will have their ticket revoked and will not be permitted to enter the event. No reimbursement for the ticket or any other costs will be given.
2. Any attendee or guest who is found consuming or possessing alcohol or drugs on the premises or any attendee who shows any sign of being under the influence of drugs or alcohol during the event (as per the "reasonable belief" of Administration) will be removed from the event and their ticket will be revoked. No reimbursement for the ticket or any other costs will be given.
3. Should an attendee or guest be asked to leave the premises for any reason, a parent/guardian will be contacted. Should there be any suspicion of an attendee being under the influence of alcohol or drugs and there is any indication that the attendee is in possession of a vehicle, Ottawa Police Services will be contacted.
4. Should an attendee or guest choose to leave the premises for any reason, they will not be readmitted. As with school dances, there are no "in and out" privileges. As a concession to support students who are smokers/vapers, there is a designated outdoor area just off of the Canada Room.
5. All people present at the Prom must provide the name and telephone number of a person that we can contact in case of an emergency. They also accept that we may contact that person if the student (or their guest) is suspected of being under the influence of alcohol or drugs.
